

# **Novation Member Loyalty Program Terms and Conditions**

# 1. Program Enrollment

a. Novation's Loyalty Program is automatically open to all members that are in good standing with \$5 in their Share Savings Account. There is no cost to be a part of this Program.

## 2. Program Qualification Period

a. Qualification for a reward in Novation's Member Loyalty Program will operate on a calendar year basis (January 1 – December 31).

# 3. Reward Qualification

- a. Novation Members who have a Savings Account and actively utilize two of the following three solutions will earn a reward (described below):
  - i. Monthly automatic deposit of at least \$1,000 (or \$12,000 per calendar year) into their Savings or Checking Account.
  - ii. At least 12 debit card transactions<sup>+</sup> per month (or 144 per calendar year).
  - iii. At least 12 Visa credit card transactions+ per month (or 144 per calendar year).
    - \*Transactions must be purchases greater than \$5. Cash advances, ATM transactions, returned purchases, disputed/fraudulent/unauthorized transactions or fees caused by check card use are excluded.

b. Attainment of these qualifications would be a reward of these options the following calendar year:

- i. Loan Reward: A 0.25% APR\* reduction off an Auto Loan or Recreational Vehicle Loan. This reduction will be based on the loan rate you are approved for based on your credit score.
- ii. Deposit Reward: A 0.25% APY\*\* rate increase on an Incentive Checking Account. Additional 0.25% applies on the first of the month in which it is turned on for the member.
  - To receive the deposit reward of 0.25%, the requirements to qualify for interest to be paid each month on the Incentive Checking Account must be met. If these requirements are not met, or for balances more than \$25,000, the Loyalty Deposit Reward will not be applied. Please refer to Novation's Account Disclosure for further details on Incentive Checking qualifications.

### 4. Current Year Qualification

a. Novation members may also qualify for the reward at any time in the current qualification calendar year by simply attaining the Program requirements outlined in #3 above. Qualification review will occur quarterly each year. The reward can be used through December 31 of that year or carried over to the following calendar year.

## 5. Tracking Towards Achieving a Reward

a. Please consult with a Novation Member Solutions Representative. Automated notifications will be provided soon.

#### 6. Reward Usage

- a. Member can choose either the Loan Reward or the Deposit Reward.
- b. The Loan Reward can only be used twice each year on either an Auto Loan or Recreational Loan. The reward is non-transferable. Members may use 0.25% reward on up to two separate loans.
- c. The 0.25% rate increase can only be used once each year on an Incentive Checking Account.

## 7. Reward Redemption Process

a. Member must proactively request reward (not automatically enabled). To redeem, call 800.369.6628.

# 8. Expiration

a. The Reward must be used by December 31 of the following year meeting the Reward Qualifications. The Reward will expire at midnight on December 31 of that year.

### 9. Exclusions

- a. The Loan Reward cannot be combined with any other loan discounts and does not apply to refinancing an existing Auto loan or Recreational Loan.
- b. Novation employees, Board members, Supervisory Committee members and their official family cannot participate in the Loyalty Program.
